A complete set of Bidding Documents may be purchased from the office Shankharapur Municipality Office, Sankhu, Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, tax clearance Certificate until current fiscal year and upon payment of a non-refundable fee of Rs 3000 till 2075/12/25 during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Sealed or electronic bids must be submitted to the office Shankharapur Municipality Office, Sankhu, Kathmandu by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on 2075/12/26. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 on 2075/12/26 at Shankharapur Municipality Office, Sankhu, Kathmandu. Bids must be valid for a period of 90 days (i.e. 2076/3/23) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as per given in table for respective titles, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2076/4/22).
6. If bidder wishes to submit Bid security in the form of cash, the cash should be deposited in Deposit Account no. 013200000194524, at Bank of Kathmandu Ltd, Sankhu, Kathmandu, on the account of Shankharapur Municipality Office, Sankhu, Kathmandu. And submit the receipt of the deposited amount of cash along with the sealed bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
